Every employee must present documents verifying identity and eligibility to work in the U.S. within the first three days after the hire date. NC State must examine the documents and record the information on the 1-9 form. NC State University utilizes an online, electronic 1-9 system for the completion of 1-9 forms.

You will need to go to the I-9 Center located at the Admin II Building, 2711 Sullivan Dr. with your unexpired ORIGINAL documentation; no copies will be accepted. No appointment is necessary and they are open Monday-Friday, 8:30 AM - 4:30PM. On the following page is a list of acceptable documents to use to complete your new electronic 1-9.

If you are an international student, the most common documents to complete an I-9 are: Passport, 1-94, and 1-20.
